Daily Drop Off/ Pick Up between 8-10 AM and 4-6 PM  
The kennel is CLOSED to the public between 10-4 daily.**

Dogs not picked up during AM checkout time will be charged for daycare.  
Drop Offs/Pick Ups outside of scheduled hours can be arranged in advance at an additional cost of \$5 per occurrence.  
New dogs are required to complete a trial day of daycare prior to their boarding dates.

**Please Read & Initial the following:**

\_\_\_\_\_ I hereby certify that the above-named dog(s) has been fully vaccinated for canine distemper, canine parvo virus, as well as bordetella (canine cough) within the last year, and rabies in accordance with local laws.

\_\_\_\_\_ I am aware that my dog may be exposed to those infectious diseases described above. However, since Barker Brook Kennels, has advised me that my dog must be fully vaccinated against those diseases before attending boarding and/or daycare; I alone assume responsibility for any such exposure. I also acknowledge that in addition to the diseases listed above my dog may be exposed to other infectious diseases. However, for my dog to participate in daycare and/or boarding, I alone assume the responsibility of such exposure to infectious diseases.

\_\_\_\_\_ I understand that while my dog is current (within the last year) on canine cough vaccination, he/she is at risk of contracting an upper respiratory infection (URI). I assume all risk and financial responsibility related to and immediately resulting from URI infection contracted while staying at the kennel. The bordetella vaccine may not be effective even if administered regularly.

\_\_\_\_\_ All pets are suggested to be on flea & tick preventative as well as intestinal parasite preventative. If a dog is found to have fleas at the kennel it may be given Frontline and/or Capstar treatment and/or flea bath at the owners' expense. I assume all risk and financial responsibility related to and immediately resulting from the infestation of fleas, ticks, intestinal parasites while at the kennel.

Occasionally pets become sick or injured while boarding/grooming. If my pet needs medical attention, I understand that every effort will be made to contact me for notification of

treatment authorization. However, in case I cannot be reached, the following procedures will be used:

If the animal becomes significantly ill or injured, or Barker Brook Kennels suspects the animal is significantly ill or injured, the owner shall be notified at once, if owner does not immediately inform the kennel regarding measures to be taken, or if the state of the dog's health requires quick action, I authorize Barker Brook Kennels to take the following action:

\_\_\_\_\_ In the event of a minor illness or injury (ear infection, skin infection, loose stool, vomiting, minor cuts, scrapes, puncture wounds, etc.) I authorize Barker Brook Kennels, to treat my pet as needed.

\_\_\_\_\_ I accept full financial responsibility for all charges related to the treatment of my pet.

\_\_\_\_\_ I understand every attempt will be made to contact me; however, services will not be withheld if I am unreachable. I will be financially responsible for all services rendered.

\_\_\_\_\_ In the event of a life-threatening condition, I understand that my pet will receive full treatment whether I am able to be contacted or not, regardless of the treatment costs. I understand that if this case arises that I will be financially responsible.

\_\_\_\_\_ I understand that group play between dogs possess inherent risks. Scrapes, bites, tears, punctures, sore muscles and possible ligament tears are to be expected. I accept full financial responsibility for medical treatment resulting in group play.

\_\_\_\_\_ I understand I will be charged for the entire reservation even if the dog is picked up early.

Should my pet remain unclaimed after the pick-up date decided, and Barker Brook Kennels has been unsuccessful in reaching me regarding further instructions, the pet shall be considered abandoned, Barker Brook Kennels will become the sole owner of said pet. I understand said action does not release me of my financial responsibilities.

I understand that Barker Brook Kennels is not responsible for loss or damage to personal items left with the pet including but not limited to leashes, collars, toys, and bedding.

I am aware that given the unpredictable nature of dogs, an interaction could take place between animals, or unforeseen events could occur while staying at Barker Brook Kennels. If such an event results in injury to my dog, to other dogs, to other people, I alone assume responsibility for any such injury.

As a courtesy to other dogs staying at the kennel, as well as neighbors to the kennel, excessive and continual barking will be controlled via ultrasonic correction monitors, if these fail to help, the use of an electronic collar may be used.

Many dogs do not wear collars while at the kennel as they pose a risk for injury and death. Collars may become caught on fencing, caught on other dog's teeth and/or paws, caught in doggy doors, etc. Collars are removed at night & nap time. I understand Barker Brook Kennels may remove my pet(s) collar if it poses a risk to my dog and/or other pets while at the kennel. Barker Brook Kennels is not responsible for injury or death resulting from an animal's collar.

I hereby waive and release any actions, cause of actions, damages, rights, claims or lawsuits which I may have for: (a) any and all personal injury or property damage which may be sustained arising out of any interaction between dogs participating in daycare and/or boarding, grooming, and (b) any and all injury, illness or disease sustained by my dog arising out of or stemming from its participation in daycare and/or boarding, grooming.

I understand that attendance at a boarding facility is not without risk to me, my dog, or my property. Some of the other dogs to which I (we) will be exposed may be difficult to control and may be the cause of injury even when handled with the maximum amount of care. There may be incidents that are beyond the control of anyone present and I assume the risk as my own solely. I hereby release and agree to hold harmless Barker Brook Kennels, the kennel attendees, business owner, property owner, and all other employees, from fault or liability of any nature, for injury or damage which I (we) or my dog may suffer.

If by any occurrence, there is loss or death of an animal in our care, due to our negligence, we will reimburse the owner with a capped amount of \$250.00.

I have read and understand this release form and I will honor and abide by the terms and conditions set forth above.
